## Performing Company Dancers

*Dancers in multiple companies use tuition pricing for the company with the greatest number of required classes. Required classes are not cumulative. Company level ballet is required of all performing company dancers.*

Mini (4 technique hours to include ballet, tap, jazz, leaps/turns/stretch)	\$200 session
Junior/Preteen/Teen/Senior (7 technique hours to include ballet (2), tap, jazz, contemporary, leaps/turns/stretch)	\$325 session
Each Additional Class Over Base Classes	\$65 session

*\*All Junior, Preteen, Teen & Senior Company dancers are scheduled for 2 weekly ballet classes during the summer session.*

## Tuition & Fee Policy

- Summer tuition and registration fee (*if due*) will be collected at the time of registration.
- Dancers from the 2023-2024 school year session (that danced in the concert) will not be charged the \$50 registration fee if continuing in the summer intensive. They are considered continuing students.
- A NSF fee of \$40 will be added to checks that are returned to us that are not paid. Please contact the office to settle your account and to pick up your check. To avoid bank charges, we do not redeposit returned checks. A Chargeback fee of \$40 will be added if your bankcard or online payment is returned.
- If at any time a past due account is not cleared by the 3<sup>rd</sup> of the new month, a monthly re-occurring late fee of \$25 will be charged until the account has been paid.
- Your account will be placed into collection status if you fail to pay in a timely manner. You will be responsible for all attorney fees, court costs, agency commissions, and other assessments incurred by ADX to collect your unpaid account balance.
